- a. listed entity having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty-five crore, as on the last day of the previous financial year;

The paid-up equity share capital and net worth of the Company as on 31<sup>st</sup> March 2022 are Rs. 3,00,00,000/- (Rupees Three Crores only) and Rs. 3,93,91,457/- (Rupees Three Crores Ninety-Three Lakhs Ninety-One Thousand Four Hundred and Fifty-Seven only) respectively.
